## **ON ELECTION DAY:**

All City of High Springs residents that are registered voters may vote on election day at their assigned polling location, Precinct 20 (High Springs Civic Center), or Precinct 60 (First United Methodist Church).

Residents are encouraged to verify and, if needed, update their registration by visiting [www.RegisterToVoteFlorida.gov](http://www.RegisterToVoteFlorida.gov) or contacting the Alachua County Supervisor of Elections office. You can register online by going to [VoteAlachua.gov](http://VoteAlachua.gov). or go in person to the Alachua County Supervisor of Elections Office. For additional voting registration information questions visit [www.VoteAlachua.gov](http://www.VoteAlachua.gov). *The last day to register to vote for this election or to update your voter's information to vote in this municipal election is February 26, 2024.*

Bring a valid picture and signature identification (see below for acceptable Identification). If you vote at the polls, and cannot show a picture and signature identification, you must vote a provisional ballot.

## **Acceptable Photo and Signature Identification**

- Florida Driver's License
  - Florida ID Card issued by the Department of Highway Safety and Motor Vehicles
  - United States Passport
  - Valid Debit or Credit Card with the voter's signature
  - Military ID
  - Student ID
  - Retirement Center ID
  - Neighborhood Association ID
  - Public Assistance ID (Social Security or other social services)
  - Veteran Health ID issued by the United States Department of Veterans Affairs
  - A license to carry a concealed weapon or firearm issued pursuant to S. 790.06.
  - Employee ID issued by any branch, department, agency, or entity of the Federal Government, the state, a county, or a municipality.
